Attention is drawn to the fact that the figures for the three months ended 31 March 2022 as reported in these unaudited financial results are the balancing figures between audited figures in respect of the full previous financial year and the published year to date figures up to the third quarter of the previous financial year. The figures up to the end of the third quarter of previous financial year had only been reviewed and not subjected to audit. Further, the Company has availed the exemption of disclosing corresponding quarterly financial results for the quarter ended June 30, 2021.

Our conclusion is not modified in respect of this matter.
